Re:	Selection of new commissioner

On Friday, July 26, 2024, the Commission will convene at 10:30 in Room 309 of the State Capitol to interview applicants and select a Commissioner to replace Commissioner Solimon, whose term expires on August 9, 2024. This special commission meeting will follow a brief, regular meeting that will run from 9:00am to 10:30am, also in Room 309.

### I. Solicitation of applicants and invitations for interviews

In May and June 2024, the Commission solicited applications for State Ethics Commissioner. To this end, the Commission purchased advertising in the *Albuquerque Journal*, the *Las Cruces Sun News*, the *Farmington Daily Times*, the New Mexico State Bar Bulletin, and Joe Monahan's political blog. The Commission also placed public service announcement radio advertisements around the state. In response to its advertising efforts and solicitations, the Commission received 22 applications. Commission staff reviewed the applications for completeness and the applicants' eligibility under NMSA 1978, Section 10-16G-4 (2019), which provides qualification criteria. Based on that review, I selected seven applicants for the Commission to interview and from which to select the next Republican Commissioner.

### II. Selection procedure for the next Republican Commissioner

In 2019, the four legislatively appointed Commissioners (then Commissioners Bluestone, Carruthers, Villanueva, and Williams) utilized a special selection procedure to select the remaining two Commissioners (Commissioners Baker and Solimon). I recommend the Commission use the same procedure for the selection of the next Republican Commissioner. The procedure is as follows:

- During each interview, the applicants are asked the same set of questions. *See* Section III, *infra*, Sample Questions. The applicants receive the sample questions before the interview, as part of the publicly available special meeting materials. The applicants do not observe the interviews of other applicants.
- 2. After the completion of the interviews, each of the four legislatively appointed Commissioners notes their respective preference ranking for each candidate, 1 through 7, on a form created for this purpose. *See* Preference Ranking Form, *infra*. The number (1) indicates the *most preferred* candidate. Only legislatively appointed Commissioners may submit preference rankings.

- 3. At the conclusion of all interviews and after each Commissioner completes their respective preference ranking, I collect the rankings and then aggregate the preference rankings corresponding to each applicant. The applicant with the lowest number will be selected.
- 4. In the event of a tie, the applicant with the greatest number of 1 values will be chosen. If two applicants have the same number of 1 values, then the applicant with the greatest number of 2 values will be chosen. If, at that point, the tie is not broken, I will inform the entire Commission, who will then reconsider and revote or otherwise take appropriate action.
- 5. After making the determination, I will communicate the results to Chair Lang, who will announce the Commission's selection. In Chair Lang's absence, I can announce the Commission's selection and inform the applicants. Staff will work on getting an oath of office executed and filed with the Secretary of State.

# II. Reasons for this selection procedure

The Commission utilized this procedure to select applicants for the final two seats of the State Ethics Commission in 2019 and then for the Commission's two appointments to the Citizen's Redistricting Committee in 2021. Several reasons support the procedure.

- 1. The four legislatively appointed Commissioners must all concur on the selection. *See* NMSA 1978, § 10-16G-3(H) (2019) ("No action shall be taken by the commission unless at least four members, including at least two members of the largest political party in the state and two members of the second largest political party in the state, concur."). Abiding by the outcome of the selection process enables the four legislatively appointed Commissioners to concur on a selection, even if the Commissioners do not agree on which applicant is most preferred.
- 2. Under the Open Meetings Act, the Commissioners may not interview the candidates and then retreat to a closed meeting to deliberate privately. The selection of a State Ethics Commissioner does not fall within the exception to open meetings for "limited personnel matters," because Commissioners are not public employees. *See* NMSA 1978, § 10-15-1(H)(2) (2013). Nor does any other exception to the statutory open meetings requirement apply. *See* NMSA 1978, § 10-15-1(H) (2013). The selection process enables the Commission to make a decision without discussing in public the merits and demerits of particular applicants.
- 3. The selection process gives equal weight to each Commissioner's individual preferences.

- What motivates you to serve on the State Ethics Commission?
- How would you handle a situation where a close friend or colleague was involved in a matter involving the Commission?
- What steps would you take to remain unbiased in your role as a Commissioner?
- What do you believe are the core principles of ethical behavior in public service, and how do you view the relationship between those core principles and the law the Commission is charged to interpret and enforce?
