## **SECTION III: NARRATIVE**

### **BILL SUMMARY**

#### **Synopsis:**

SM 7 is a memorial requesting a redistricting task force be convened to review the Redistricting Act NMSA 1978 Sections 1-3A-1 to -9 (2021) and make recommendations on how to improve New Mexico's redistricting process, including proposed legislation to implement the recommendations. The memorial emphasizes the importance of a culturally, economically, and geographically diverse task force with representation from across the state.

The Task Force would consist of 13 to 15 members. Members would be appointed one each by the president pro tempore of the senate, the speaker of the house of representatives, the minority floor leader of the senate and the minority floor leader of the house of representatives (four total). The state chairs or designees of each major political party would also serve as members. The remaining seven to nine members would be appointed by the State Ethics Commission and would be selected from the following categories:

- at least three members not affiliated with a major political party;
- at least one member of the 2021 citizen redistricting committee;
- two representatives of Indian nations, tribes or pueblos; and
- one member with experience in demography and geolocation
- may include representatives from state organizations that work on voting, elections, government transparency and democracy.

The Task Force must present its findings and recommendations to the New Mexico legislative council and at least two additional interim committees for discussion by December 31, 2027.

Legislative Council Service would provide staffing support for the Task Force.

### **FISCAL IMPLICATIONS**

Fiscal implications for the State Ethics Commission include staff or contractor time associated with advertising the opportunity, soliciting and vetting applications, and preparing appointment materials for Commission consideration. The memorial may also require additional Commission meeting time to review applicants and approve appointments. The memorial does not include an appropriation.
